

# Healthcare Expo Promotion

## Terms and Conditions

### 1. Introduction

The promoter of the Healthcare 2040 Expo ("event") promotion ("Promotion") is MyPracticeManual Pty Ltd ABN 150 460 129 trading as Avant Practice Solutions ("Promoter") of Level 6, Darling Park 3, 201 Sussex Street, Sydney, NSW 2000 and Darjack Pty Ltd ABN 88 129 476 295 trading as Cgov ("Promoter"). These terms and conditions ("Terms and Conditions"), as updated from time to time, govern the Promotion.

### 2. Who can enter?

- a) To enter, you must be over 18 years of age
- b) You must have been invited by Avant Practice Solutions or Cgov to attend the event, and visit the Avant Practice Solutions and Cgov stand to submit an entry into the competition.
- c) Directors and employees of the Promoter and its related bodies corporate (as that term is defined in the *Corporations Act 2001* (Cth)) ("Related Bodies Corporate"), and immediate family members of each of these persons are ineligible to enter.

### 3. Promotion Dates

- a) The Promotion will commence at 8am ADST on 11 March 2026 and close at 5pm ADST on 12 March 2026 (the "Promotion Period").

### 4. How to Enter

- a) The Promotion is free to enter.
- b) To enter you must, during the Promotion Period, visit the Avant Practice Solutions stand and provide your name, phone number and email address.
- c) Each person submitting their details and satisfying the requirements will automatically have their name entered into the draw. Entries received outside the Promotion Period will not be considered.
- d) Only one entry is permitted per person.
- e) Incomplete or illegible entries will be deemed invalid.

### 5. Prizes
